Dear Danish Consumer Council,

Thank you for your letter regarding the compliance testing of Temu products and for the opportunity to address the concerns you have raised.

We have carefully reviewed the issues highlighted in your correspondence, specifically the results of your tests on baby toys, USB chargers, and necklaces offered through the Temu platform. We note your finding that 26 of 27 baby toy products, 26 of 27 USB chargers, and 1 of 27 necklaces were identified as non-compliant with EU product safety legislation. In response, we have identified a total of 53 products matching these descriptions on our platform. The product details (category and product IDs) for these 53 items are as follows:

# 1. Consumer Reports and Handling

Regarding consumer complaints, we received a total of four consumer reports related to these products. Each report expressed consumer concerns but did not contain further evidence or technical details. Therefore, our initial assessment relied on the compliance documentation

provided by the sellers to verify product safety. Based on the documentation provided by the sellers at that time (such as product compliance certifications, test reports, and packaging labels), our initial review did not confirm non-compliance based on the documentation available at that time. However, we took each report seriously and advised consumers to contact customer service for further assistance.

To provide full transparency, we have summarized below the consumer reports we received and the actions taken at that time. Supporting documentation and test reports submitted by sellers are provided in **Annex I.**

#### 2. Assessment Based on Additional Technical Information

Upon receiving additional technical information and supporting materials from Tænk and Stiftung Warentest, we conducted a further review of the products concerned. We immediately removed the products in question from sale and notified the respective sellers of the issues. Subsequently, we have received further feedback and supplementary information from several sellers. In line with our internal procedures, we reviewed these information carefully and provided feedback to your organization on August 13, 2025 regarding some of these products, and on October 17, 2025 to Stiftung Warentest regarding others, together with detailed explanations of our findings.

Detailed records of the seller appeals, correspondence, and our internal review notes are provided in **Annex II**. We are currently awaiting feedback and confirmation from both your organization and Stiftung Warentest before proceeding with further coordinated actions, including identical-product identification, potential recall measures, and additional consumer-protection steps if required.


## 3. Corrective Actions and Next Steps

For the remaining products among these 53 that were confirmed to be non-compliant and potentially dangerous, Temu had already taken immediate action at that time by removing them from sale and notifying the respective sellers. While awaiting further information on corrective measures from the sellers, Temu has initiated a voluntary recall for those products that were determined to present a high risk to consumer safety, while proportionate measures (e.g., delisting, controls on identical listing, and enhanced monitoring) are applied to other cases pending any escalation. The recall is underway and is targeted for completion around mid-November 2025. We will inform you by e-mail as soon as the recall has been completed. The product IDs for the recall are as follows:

Regarding products similar to those tested, we conducted a further review of the 53 items and confirmed that they have been removed from sale across all Temu EU site. At the same time, for those items not under dispute, we have identified and delisted any identical product listings. If you or other consumer organizations become aware of similar products that remain available for sale, we would appreciate it if you could share the relevant URLs with us so that we can further investigate. We will take prompt action, including reviewing our algorithmic and manual detection processes.


Finally, concerning the availability of baby toys on the Danish Temu site, our recent review indicates that baby toys are currently available for purchase in Denmark.
